We are running a little late for this addition because we wanted to include information regarding the Grand Opening of the Nebraska Vietnam Veteran's Memorial (NVVM) in Papillion, Nebraska, Please take the time to read the article in this edition. It may seem that efforts to get our "Lost 74" on the wall have slowed down, but that is not the case. Since the last update the Government Accountability Office (GAO) is well into their investigation and has completed their outreach and interviews with several survivors and relatives of the lost. A couple of our relatives of the lost addressed in their interviews how it appears the decisions of who has been added or not added since the wall was erected have been somewhat arbitrarily applied and that there does not seem to be a clear policy for inclusion, but rather the decision making appears to be purely political in nature. If the politics of the situation were removed, then we would be able to figure out how to overcome the logistical and funding obstacles. Our survivors related how they relive that tragic night daily and drove home the point that our ship and crew were there for one reason and one reason only, to fight in the Vietnam War.

We are receiving great support from the Vietnam Veterans of America (VVA). As you know the VVA has a resolution supporting the addition of the "Lost 74" names added to the Wall. For those that are not a members of VVA, please consider joining. More information will be forth coming regarding their thoughts going forward and how they are doing research in an effort to help or cause.

PAPILLION NEBRASKA ROLLS OUT THE RED CARPET BY STEVE KRAUS


Papillion Nebraska certainly rolled out the red carpet not only for our "Lost 74" but for the USS Frank E. Evans Association on 6 June 2024. I was blown away with the warm reception we all received at the Grand Opening of the Nebraska Vietnam Veterans Memorial in Papillion, Nebraska. The memorial is located at 11691 South 108th Street, Papillion, NE 68046

On 5 June a pre-grand opening event was provided to special guests, association members, army crew members that once flew the UH-1 Huey aircraft and others that played a role in helping make the Nebraska Vietnam Veterans Memorial become a reality.. The Huey aircraft is permanently on display and a center piece of the memorial. The Nebraska Vietnam Veterans Memorial Organization was able to locate, obtain and restore the aircraft to precision and perfection. On the ground below the helicopter is a statue of two army soldier's carrying an injured veteran as they await for the chopper to land.





Directly in front of the nose of the helicopter is the memorial to our "Lost 74". It is located at one of the two entry points for the Nebraska Vietnam Veterans Memorial grounds.



On the backside of the wall are all 400 tiles representing the 400 names inscribed on the NVVM.













SPECIAL TRIBUTE

In Memory of John Coffey

9/27/1944 to 3/7/2024

There are special people in our lives who will never leave us. They leave us in body, but never in mind. John Coffey was one of those people. The days John was with us might fade away, but his memories, moments, quick wit and laughter, will never fade away!



John had an impact on each of us. He was not just a person; he was a force - a beacon of kindness, resilience, and unwavering love. You never left his presence without a smile. He never took life too seriously and lived life to the fullest everyday. The world is not the same without John Coffey.

This is what John wrote in his bio explaining how he grew up. It demonstrates his humor he put into every conversation.



It was a dark, cool, windy night on September 27 of 1944, when after hours of crying, sobbing, and more crying, my dad finally paid the hospital bill and was able to take me home for the first time. After graduating high school at age 17, I couldn't find a job because I wasn't signed up for the draft. So, I asked my father to sign the papers that would let me join the service, I almost burnt the soles off my shoes getting my father to the 5 & 10 cent store, where there was a notary to witness the signing. I was a company commander in the JROTC in high school, so I knew a little bit about the military. Two year's reserve was enticing, so off to the reserve unit I went. I attended NTC San Diego. I was given orders to report aboard USS Frank E Evans (DD754). Shortly after reporting aboard, I did a variety of painting jobs, they were endless. A few weeks later Evans headed to sea for shakedown training. While at sea I was assigned to paint a little square space about 3x3x3. It was two decks down in the bow of the ship, no ventilation, just paint fumes. I was getting sick when a voice called out, "Coffey". I knew I had led a life that would not warrant the voice of God calling me home, so I answered the call and was told to report to the Lieutenant. Still trying to keep from throwing up I entered his stateroom. The lieutenant told me I had good battery test scores and would I like to become a radarman. I was staring at his shoes, trying not to throw up, this was a chance to get out of painting. I said, "Hell Yeah". The Lt responded, "What?" Then I said "Sorry, sir, yes I would appreciate that opportunity. After being discharged, I went to work with the Atlanta Coca Cola Bottling as a route salesman and was advanced to Supervisor. I left after 15 years and ran beer routes. I eventually hired on with AT&T where I worked for a few years, until AT&T split and I went to Lucent Technologies. I became a manager, a report writer, and finally a financial analyst. I married Judy on December 31, 1993. I was very happy, having nothing to do but what my wife told me to do. Kind of makes me miss the Navy.

John Coffey Tribute Continued

USS Frank E Evans records indicate RDSN John David Coffey dropped his seabag on the Quarter Deck of Evans on 4 January 1963. Like those sailors before him, his on-the-job training started with a chipping hammer. The Navy knew his aspirations were <u>higher</u> than chipping paint on the main deck so they moved him up a few decks and introduced him to chipping paint where the wind blew harder and the air was cleaner.

John finally got his chance to be a scope dope (Radarman.) He trained and learned the duties of a Radarman for the remaining time he had in the service. John fit in with his other shipmates, he worked hard, played hard and kept is focus on completing his obligations to the US Navy in 1964.

John was sarcastic, funny, loving, and a no BS man; he told you what he thought whether you liked it or not. He loved his family, friends, grandchildren, Judy, CJ (his adored chihuahua), dirty jokes (the raunchier the better), University of Georgia and Kennesaw State football, NASCAR, and the Waffle House. Marni tells a story that, when growing up, if she needed her dad, she would call the nearest Waffle House to his home and ask for "the man sitting alone and reading a book" to which they always handed the phone to her dad.

Fast forward to 1992, the date is 25 September 1992, the place Hilton Conference Center, DFW/Grapevine, Texas, first official USS Frank E. Evans DD 754 crew reunion. The Association had yet to be formally organized. Who pops into meet the attendees, John D. Coffey, he thought there was free beer... It was free because John was buying it.

October 2014 John attends his first Board of Directors meeting as a guest at the Doubletree Hotel, Seattle Washington. In 2015, in Mobil Alabama, John was elected to the Board to fill a new position; Director of Communications. John soon found out that there wasn't any free beer at the board meetings either. John remained on the board for the next 10 years providing ideas for better communication, upcoming events and ways to make the board more effective. John volunteered for whatever and whenever, never complained (well almost never complained) and completed his projects on time. John took over the position of notifying Association members on deaths, needed prayers, upcoming events and general announcements through email. John created the very first Face Book page and posted to it until he was jailed by the Face Book Police. They considered his postings inappropriate. Another task he performed was master of ceremony for the dedication of eleven (11) out of 28 "Lost 74 Memorial Stone Dedications."

John is survived by his daughter, Marni and husband Carl Hicks; grand-kids, step-son Steven Polvere and wife Laura; step-daughter Amber Polvere; grandson Jarrett Hicks and Fiancé Tabitha Brewer; and grand daughter Jordan Keller and husband Trey Keller.



She worked tirelessly over the years to help gain recognition to have Ensign Allen Herbert Armstrong's name added to the Vietnam Veterans Memorial in Washington D.C. Ann was a soft spoken individual who cared about others before herself. The association grew to love Ann not for the work she did but for who she was; kind, considerate, caring, helpful and most of all loving, she will be sorely missed."
